1. [The Government of Nepal [GoN]] has allocated funds towards the cost of [Cold Store Nirman Khadak Na.Pa. 7] and intends to apply part of the funds to cover eligible payments under the Contract for [KHDK/W/NCB/11/081/82]². Bidding is open to all eligible as per Section V of bidding document.
2. [Khadak Municipality, Office of the municipal executive, Kalyanpur, Saptari] invites sealed bids or electronic bids from eligible bidders for the construction of [Cold Store Nirman Khadak Na.Pa. 7]³ under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: [enter NRs. 93,000,000.00]
- Minimum Work experience of similar size and nature: [at least on project with NRs. 37,100,000.00 Bid Capacity NRs. 56,000,000.00

CONCRETE 1:1.5:3OR RICHER MIX: - 200.00CUM.

PUFF PANELWORKS: - 880.00SQ.M

MS IRON WORKS: - 16 MT.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document [NRs. 5,000.00] in the Project's Rajaswa (revenue) account as specified below .

Information to deposit the cost of bidding document in Bank:



6. Pre-bid meeting shall be held at *[Kalyanpur, Saptari]* at *[1:00 pm on December 9, 2024]*.⁴
7. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before *[12:00]* on *[Friday December 20, 2024]*. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at *[2:00 pm Friday December 20, 2024]* at the office of *[Kalyanpur, Saptari]*. Bids must be valid for a period of *[120 days]* after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of *[NRS. 2,100,000.00]*, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
