5. Sealed or electronic bids must be submitted to the office Khadak Municipality, Kalyanpur, Saptari, Madhesh Province, Nepal through **PPMO** website www.bolpatra.gov.np/egp on or before **05-06-2024 12:00**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **05-06-2024 14:00** at the office of Khadak Municipality, Kalyanpur, Saptari Madhesh Province, Nepal. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of amount mentioned in table below, which shall be valid for **30 days** beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
